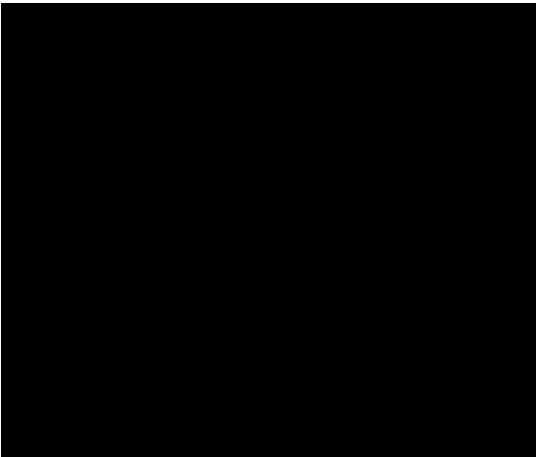

**a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)**

Random Access Meadery Ltd is committed to promoting all four licensing objectives by ensuring that all alcohol production, storage, and online sales are carried out responsibly and safely. We will implement strict procedures for secure storage of alcohol, responsible online sales with age verification, and clear policies to prevent crime, public nuisance, and harm to children. Staff will be trained in legal requirements and responsible alcohol handling.

**b) The prevention of crime and disorder**

All mead products will be stored securely in lockable storage areas. Access will be limited to authorised personnel only. Online sales will require verified customer accounts and secure payment processing to prevent fraud. Any incidents of attempted illegal sales will be reported to the relevant authorities. Delivery will only be made via reputable couriers who check identification upon delivery.

**c) Public safety**

All production and storage areas will comply with health and safety regulations, including proper ventilation, fire safety measures, and equipment maintenance. Staff will be trained in safe handling of alcohol and brewing chemicals. Risk assessments will be conducted regularly to identify and mitigate any hazards.

**d) The prevention of public nuisance**

Since Random Access Meadery Ltd operates online only, there will be no customers visiting the premises, eliminating public disturbance. Deliveries will be scheduled during normal daytime hours to minimise noise. Waste and recycling will be managed responsibly to avoid impact on neighbours and the local community.

**e) The protection of children from harm**

All online alcohol sales will include robust age verification systems to ensure that no alcohol is sold to persons under 18. Staff will be trained in recognising and preventing attempts by minors to purchase alcohol. Marketing materials will not target children and will include responsible drinking messages.

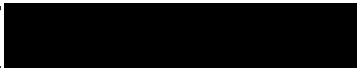

  - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
